Official Launch of a selection test for the recruitment of three thousand (3,000) primary school teachers for the sixth phase of the third Contract Teacher Programme for Nursery and Primary Education in Government Primary Schools under the Ministry of Basic Education, for the 2024 session.

## **DECIDES:**

- Article 1.- (1) This decree shall launch a selection test for the recruitment of three thousand (3,000) Nursery and Primary School Teachers to teach in Government Primary Schools in Cameroon.
- (2) This written test shall be held on **Saturday, 23 November 2024**, in all the Regional capitals.
- Article 2 (1) Candidates are called upon to apply for this test based on the needs of the schools (job posting). Each candidate shall choose a school in which he or she would like to work in and sit in for the test at the regional exam centre in the area he or she has chosen.
- (2) However, if the quota allocated to a school is attained, the Ministry of Basic Education may assign successful candidates to another school in need which is located in the same region which has not registered any applicants.
- Article 3.- Allocating seats and quotas by region and division are based on the needs of the target schools mentioned in article 2.
- **Article 4**.- The list of eligible schools mentioned above will be published ahead of time by the Ministry of Basic Education, and all applicants will be asked to specify, in a motivation letter attached to their application, the school they wish to take the test in.

### Article 5.- CONDITIONS TO BE MET TO APPLY.

Cameroonians of both sexes who fulfil the following conditions are eligible to apply:

- a) Be at most 40 years of age by 31 December 2024.
- b) Holder of a CAPIEMP issued no later than 2019.

**Article 6**.- The selection test is open to all holders of the 2019 CAPIEMP and to all holders of previous CAPIEMPs, regardless of previous participation phases of the third recruitment programme. Candidates are required to submit an application file, details are set out in article 7.

### Article 7.- COMPILATION OF APPLICATIONS.

- (1) Applications submitted to the Regional Basic Education Delegations by **25 October 2024** shall include the following documents:
  - a. A stamped application addressed to the Minister of Basic Education;
  - b. Two passport size photos (4X4 format);
  - c. A certified copy of the birth certificate;
  - d. Two certified copies of the CAPIEMP or Teacher's Grade One Certificate;
  - e. An unstamped photocopy of the professional diploma;
  - f. A certified photocopy of the National Identity Card;
  - g. A bulletin n °3 of an extract of a non-conviction record (not less than 3 months old);
  - h. A medical examination bulletin;
  - i. A civil status information sheet;
  - j. An information sheet of the candidate, a sample shall be collected in services of each Regional Delegation of the Ministry of Basic Education;



- k. An undertaking to honour and serve in this position of assignment for 5 years;
- l. A letter of motivation from the candidate specifying the school chosen;
- m. A certified copy of a marriage certificate (if any).
- n. A certificate of residence in the requested region.
- o. An A4 envelope, stamped with the candidate's address.
- (2) Any incomplete or late application shall be rejected;

(3) Candidates shall submit their applications exclusively in the Region which lodges the chosen school and whose capital is necessarily their composition centre;

(4) All examination centres are bilingual.
